LATE PENALTY FEE

That additional fee of R50 for every 15 minutes shall be payable in the event of the collection of our/my child from the school after the school attendance hours, namely, after 17h30.

GENERAL

- I/we shall ensure that the child is immunized against normal contagious diseases before attending the school.
- That any medication that my/our child requires during school hours shall be handed to a staff member together with an instruction, otherwise the school shall not be responsible, therefore.
- That if my/our child has any contagious illness, they may not attend school.
- My/our child must be personally handed over to the staff member on reception duty by the office gate and under no circumstances my my/our child be left at the entrance of the school or in the parking area. The school takes no responsibility for a child that is left unattended at the school entrance. My /our child shall not be allowed to leave the school unattended.

School times: Children should arrive at school no later than 08:00 each morning.

School Hours: 06h20 – 17h30

Please note closing time is strictly at 17:30 and parents will be held liable for a penalty fee of R50 in the case of a late pick up. The reason for this penalty is that our teachers/assistants cannot reach their transport in time and then must pay additional bolt/taxi money to get home. I am sure you will also realize that this is unfair to them.

School Holidays

We are open during school holidays (excluding public holidays) when a holiday program will replace our normal program. The school will be closed for a portion of the December holiday, advanced notice of these closing dates will be given.

NB: School fees are still payable during holidays, even if your child does not attend.

Meals

We offer breakfast, a mid-morning and mid-afternoon snack as well as a well-balanced lunch each day. Please do not send any snacks with your child.
